1. INTRODUCTION

The Community Services Directorate of Msinga Local Municipality is embarking on a project of analyzing a provision of Free Basic Services in the municipality for sustainable provision of services and service delivery. Msinga Local Municipality has a duty to develop, implement, monitor and review Indigent Register as per its Indigent Policy adopted on annual basis. The project is aimed at verifying all municipal applicants specifically those that are earning an income not exceed the thresholds of **R3200. 00** per month.

2. PURPOSE OF THE PROJECT

The project results must yield a **Credible Indigent Register** for Msinga Local Municipality and improve the revenue collection of the municipality. In terms of the Constitution of 1996, everyone has a right to access basic services.

The projects therefore, aims at providing options for the municipality to determine the households who qualify for free basic services. The project will focus only on the households/applicants that have already submitted their information to the municipality.

3. OBJECTIVES OF THE PROJECT

Due to high levels of unemployment and inadequate economic development within the municipality, there is a huge need for the provision of free basic services to the indigent households. Thus, the project aims at verifying the status of applicants in order to link information with the Billing System and other free basic services. This data cleansing initiative will assist the municipality to determine which household/applicant still qualify for free basic services and which household/applicant whose status has changed over time which the municipality might have to bill to increase its revenue collection.

4. THE ROLE OF SERVICE PROVIDER

The role of Service Provider is to analyze required data and present the findings. All activities and findings of this projects must be in line with Msinga Local Municipality's Indigent Policy.

5. PROJECT COVERAGE

This project targets all applicants from all 18 wards in Msinga Local Municipality.

5.1 Scope of work

- To identify if the applicant is indigent or not;

- To provide employers address of an applicant or employers address of dependent employer (if applicable);
- Verification of contact details;
- Confirmation of unemployment, business connection (if applicable) and documentary proof of income;
- To inform the municipality if there is a change to the status of employment to the applicant;
- To verify the dependent(s) status (if applicable);
- Verification of Identity (ID) numbers;
- To prepare death reports of indigent applicants;



5.2 Management

In case where the appointed services provider appoints the services other consultants or sub-contractors, the appointed service provider will take responsibility of the work of sub-contractors.

6. EDUCATION AND CAPACITY BUILDING

The appointed service provider will be required to transfer skills and share knowledge on this nature of the exercise with the Msinga municipal' officials within the institution during the time of the project.

7. DELIVERABLES

A credible Indigent Register shall be submitted in 2 hard copies and electronic version (computerized system) to the attention of the Municipal Manager, Msinga Local Municipality. All correspondence shall be done through the Project Manager responsible for this project (Director Community Services).

8. TIME FRAME

It is estimated that the project should be starting immediately from the date of project awarding.
